#### Minutes

The minutes of the regular meeting of December 7, 2020 were read and approved on a motion made by Mayor Zerr and seconded by Commissioner Erwin. Motion carried 2-0.

# **Warrants**

The warrants and overtime for the month of December were reviewed, approved, and signed by the Commissioners.

#### **CDBG-CV Grant**

CDBG-CV Grant Drawdown #6 was presented. Mayor Zerr made a motion to approve CDBG-CV DD #6 in the amount of \$7,191.41. Erwin seconded the motion. Motion carried 2-0.

### **Hoxie Housing Authority**

A request by the Hoxie Housing Authority board to put the Housing Authority director on the City's insurance was discussed. A single policy for the director would be added to the City's insurance and the Housing Authority would reimburse the City for the premium. Erwin made a motion to allow the director to be added to the City's Blue Cross and Blue Shield policy provided she is eligible. Mayor Zerr seconded the motion. Motion carried 2-0.

#### **Hoxie Elks Lodge grant**

The Commissioners agreed to write a grant to Greater Northwest Kansas Community Foundation for flooring at the Hoxie Elks Lodge.

#### **Police training**

Chief Boese asked permission to attend training in Mulvane, KS in March. Boese indicated that he would receive 20 continuing education hours for the training. Cost of the training is \$200.00 plus \$98.00 per night for 4 nights. Zerr made a motion to allow Boese to attend the training. Erwin seconded the motion. Motion carried 2-0.

## 2-wheel drive pickup

Washburn informed the Commissioners that the City has a 1993 2-wheel drive pickup that is no longer needed. He will check to see what it is worth and sell it.

### Water school

Washburn also informed the Commissioners that he would be attending water school in Hill City on January 12<sup>th</sup>, along with Justin Armknecht and Derek Vaughn.

#### **Storm Siren in Sunrise Addition**

Discussion was held on putting up a storm siren in the Sunrise Addition. Washburn will get bids.
