## **Minutes**

## Pool business

Macalee White, pool manager, entered the meeting. White informed the Commissioners that Hoxie Rec requested permission to have a swim meet on June 11<sup>th</sup> and possibly June 3<sup>rd</sup>. The meets would last from 8:00 a.m. to 1:00-1:30 p.m. so they pool would open late on those days. The Commissioners gave them permission to have the swim meets. White was contacted by Whitney Zerr with Sheridan County Health Complex. They are wanting to provide a sunscreen dispenser at the pool with SCHC logo on it to promote skin safety and skin cancer awareness. They will provide 5 bottles of sunscreen and will donate more if we run out, as long as kids don't abuse it. White exited the meeting at 7:09.
