

City of Selden
City Council meeting minutes
January 11, 2021

The Governing Body of the City of Selden met in regular session on Monday, January 11th, 2021 at the Selden City Office. The meeting was called to order at 7:03 pm by Mayor Koerperich. Present were: Bernie Koerperich, Mayor; Steve Rogers, Jacque Boultinghouse, Dusty Spresser, Danielle Schiltz, and Tammie Stevenson, Council Persons; Leroy Spresser, City Superintendent; Judy Rogers, Library Board; and Jacqueline A. Neff, City Clerk.

The Pledge of Allegiance was recited at this time.

The floor was turned over to Judy. She presented the Library budget. She also stated that Leanna Schultz will be resigning May 1st. Nicole Schiltz has stated that she will take her position. Alisha Brantley's term will also be up on May 1st. She has stated that she would be willing to stay on the board. Danielle motioned and Jacque motioned to appoint Nicole to replace Leanna and to reappoint Alisha to the board. The motion carried.

Bernie tried to call Brandon for a conference call. Brandon did not answer.

Bernie opened the floor for nominations for President of the council. Dusty nominated Danielle. Dusty asked for nominations to stop. Dusty motioned and Steve seconded to appoint Danielle as President of the council. The motion carried with Danielle abstaining.

Jacque motioned and Dusty seconded to appoint the Sheridan Sentinel as the official city newspaper. The motion carried.

Jacque motioned and Danielle seconded to appoint Steve Hirsch as the city attorney. The motion carried.

Jacque motioned and Danielle seconded to appoint Brandon Carver as the Chief of Police. The motion carried.

Jacque motioned and Danielle seconded to name The Bank as the official depository for the City. The motion carried.

Danielle motioned and Dusty seconded to appoint Tony Haffner as the Municipal Judge. The motion carried.

The council went over the minutes from the December 14th regular meeting. Steve motioned and Tammie seconded to approve the regular meeting minutes. The motion carried.

Bernie reminded everyone that the employee Christmas party is this Saturday at 6:30 in Colby.

Bernie was able to get one of the exterior lights at the Community Building working today. He also replaced the 100 amp and 20-amp breakers at the City Office.

The council went over the monthly voucher list. Dusty motioned and Danielle seconded to approve the vouchers and warrants be drawn on the Treasury for the same. The motion carried.

Berne stated that the I-pads have been delivered. The smart board has not arrived. Bernie stated that we will be refunded for it and it will need to be reordered.

Leroy stated that he has ordered 200 gallons of unleaded to be used for mowing this summer.

Brandon called at 7:28 p.m. He asked that the council look at raising the court costs to match the county court costs which are \$108.00. The county will be switching to Digi Ticket and it will be easier for the officers when writing a ticket if both are the same. He also stated that the city needs an ORI number. Steve Hirsch is working on getting it.

After discussion about raising the court costs Jacque motioned and Danielle seconded to adopt charter ordinance 15 raising the courts costs to \$108.00. The motion carried.

Leroy stated that the city supervisor for Rexford, Randy, has talked to Leroy regarding the sharing of the purchase of a leak detector. It was decided to not pay for half of it and if needed, we would rent it.

The fourth of July and spring clean up will be on the next agenda.

There being no further business, Dusty motioned to adjourn the meeting at 7:53 p.m. Steve seconded, the motion carried and the meeting adjourned.
